



EMPTY PROPERTY RATES



New regulations for the rating of empty properties came into effect on 1st April 2008. From that date the following regulations apply:-

Property Type	Rate Free Period	Thereafter
Industrial/Warehouse	6 months	Full Rates
Shops, Offices & Other Commercial	3 months	Full Rates

Notes:

1. The Rate Free Period is calculated from the date the building first became empty and not from 1st April 2008.
2. Vacant listed buildings qualify for 100% rates relief whilst unoccupied.
3. Charities and other non profit making bodies may claim up to 100% void rates relief on any vacant properties.
4. Vacant properties where the occupier is in receivership also qualifies for 100% void rates relief.
5. The rates liability of partly occupied property has the same treatment as shown above for the part which is vacant.
6. In addition to the above, there is exemption from payment of empty property rates for Small Properties with an RV of less than £18,000 for Rate Years 2009/10 and 2010/11; but for 2011/12, the RV threshold is reduced from RV £18,000 to RV £2,600.
